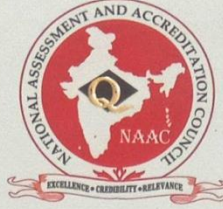

I. The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.

II. Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.

7. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other courses like UGC, the State Government etc, wherever applicable.







NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Akal College of Physical Education, Khaura No. 219, Hadbast No. 66, Khewat No. 475, Khatanni No. 958, Revenue Estate, Village - Bahadarpur, Plot No. 219, Mastuana Sahib, Distt. Sangrur -148001, Punjab for conduction of M.P.Ed. Course of Elementary level of two year programme (or 4 semesters) with an annual intake of 40 (Forty only) from the academic session 2012-13 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfilment of the following conditions:-

In case if the land is in the name of the Society/trust, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.

8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
